It should also include: Title, author's name, institutional affiliation, e-mail address, phone number, and sub-theme.

FULL PAPERS

The full papers for accepted abstracts should be submitted by **23rd May 2025**. Full Papers should be between 3000 and 5000 words prepared in Times New Roman Font 12, spacing 1.5. Cover page with Title of Paper, Abstract (300 words approx.), Keywords, (max 5), Introduction, Materials and Methods, Results, Discussions, Conclusion, Recommendations, References
